Met with Attorney General Richard Blumenthal
Regarding Anti-Chiropractic Media Campaign

HARTFORD, Connecticut (June 24, 2008)

Representatives from the Connecticut Chiropractic Council (CCC) on behalf of the Doctors of Chiropractic in the state of Connecticut were invited to meet with Connecticut Attorney General Richard Blumenthal on Tuesday June 24, 2008.

This was the result of an 18 page detailed document that was sent to the Attorney General's office from the CCC Board of Directors this month. The document, which included graphic photos, specifically outlined the three year Anti-Chiropractic campaign waged by Victims of Chiropractic Abuse (VOCA) and the Chiropractic Stroke Awareness Group (CSAG).

The Attorney General had specific opinions, comments and action steps that will be brought out shortly. For now, please look forward to the next update as his office will be conducting an additional review over the next two weeks with regard to anti chiropractic statements regarding practice and clinical guidelines.
